#### **Lux Park**

Lux Park Leisure centre was open after the pool closure while work was undertaken to reline the swimming pool, a full refurbishment of the wet side changings rooms was also being undertaken and would be reopened to the public on Saturday 1st February. Several hundreds of thousands of capital work had gone into Lux Park which was long overdue. The next phase is to install more solar panels on the building and upgrade energy efficiency. It was important for the community to use the pool and other facilities at Lux Park.

# **Devolution**

The government's devolution white paper had been published before Christmas. The government are looking to create strategic authorities with populations of around 1.5 million, this means Cornwall would not be large enough to be classed as a strategic authority on its own and would need to look to work with neighbouring authorities to benefit from the powers and funding outlined in the devolution white paper. Devon CC, Plymouth UA and Torbay UA had expressed an interest in creating a South West Peninsula Combined Authority to include Cornwall. However, Cornwall Councillors had backed a motion to not countenance any cross-border deals. It was unlikely that Cornwall would benefit from any devolution settlement in the short term, as the government would focus on those areas where there is agreement like Wessex and the South East of England.
