**Town Clerk's Comment:** – there has been some discussion amongst groups considering participating in exchanges and matches with teams in Quimperle. One Club possibly looking at an application before the end of the financial year (£400 ferry costs). Another Club are looking to go in May. Their costs might fall in this financial year (£540 passport costs – for young people that don't have them.). Both groups have been sent the Town Council's grant application.

**RECOMMENDATION:** That the Town Council consider the request for £300 grant from the Cornwall International Male Choral Festival.

## **15. FREEDOM OF THE TOWN – ROYAL NAVY (MINUTE 144/20)**

**To note the suggestion and offer of “affiliation” of the town of Liskeard to the “Fleet Operational Standards and Training (FOST) based at HMNDB Devonport.**

Background – the Town Council has previously considered the award of the “Freedom of the Town” to the Royal Navy. “Minute 144 / 20 FREEDOM OF THE TOWN – ROYAL NAVY – Following consideration of the issue and with HMS Tamar mentioned as an ideal possible vessel, to investigate the granting of the Freedom of Town to a unit of the Royal Navy (possibly HMS Tamar).

Note - Torpoint Town Council extends the Freedom of the Town to HMS Raleigh (as training establishment). Helston Town Council extends the Freedom of the Town to RNAS Culdrose (as an airfield establishment). Falmouth Town Council used to extend the Freedom of the Town to HMS Cornwall. However, when the ship was decommissioned the Town Council chose to extend the Freedom of the Town to the RFA (Royal Fleet Auxiliaries) which ships are refitted at Falmouth Docks.

Update – HMS Tamar eventually did not prove to be a viable option. In the intervening time, the Town Council extended the Freedom of the Town, to the Royal British Legion and the Royal Naval Association (RNA). A number of service men and retired naval personnel live in Liskeard. These include: WO1 Neil Walsh and Terry Whitty, both of whom have suggested and supported the offering of the Freedom of the Town to the Fleet Operational Standards and Training (FOST) which unit is operating from His Majesties Naval Base Devonport. Offer of the Freedom of the Town – Contact has been made with the local commanding officer Captain Ollie Huckner RN regarding the Freedom of the Town. He has responded very positively as below. Notably, suggesting given the limited staff compliment the Town Council seek to a “affiliate” with the Fleet Operations Standards and Training (FOST).

“Given the requirement for the formal affiliation to be approved by the Royal Navy’s Senior Leadership Team, we will present your offer of Freedom, together with our recommendation for a formal affiliation (which would reduce the requirement for the ceremonial burden of a Freedom of the town parade) to the Chief of Staff at Naval Regional Command Wales Western England & Channel Islands, NRCWWE&CI for the Naval Regional Commander (NRC)’s consideration and endorsement, and to commence the process for a formal affiliation.”

**RECOMMENDATION: That the Town Council supports and works towards the “affiliation” option which might be more operationally achievable than a “Freedom of the Town.”**
