<b>1</b>	<p><b>Welcome and Apologies</b></p> <p>Rachel welcomed everyone to the meeting and thanked them for coming.</p> <p>Apologies were received from Mike Allsopp (Liskeard Radio), Dan Sturrock (Workshed), Paul Baxter (Library), Emma Julian (Treasure Chest)</p>	
<b>2</b>	<p><b>Lights Up Event 30<sup>th</sup> November</b></p> <ul style="list-style-type: none"> <li>• The Cornish language trail – is in progress. Stuart House is the start of the Trail. Jenny will check if an activity is available as well as collection of the maps and stamp cards. What questions venues have will be finalised at our October meeting so they can be confirmed by the print deadline of 28<sup>th</sup> October. Venues can suggest their own question. The printed materials to be ready for Monday 11<sup>th</sup> November for distribution to the teams. CTC have confirmed they are happy to have any question.</li> </ul> <p>The questions last year were:</p> <ul style="list-style-type: none"> <li>○ How are you?</li> <li>○ What colour do you like?</li> <li>○ What is this?</li> <li>○ Can you count to five?</li> <li>○ What would you like for Christmas?</li> </ul> <ul style="list-style-type: none"> <li>• Mandy has asked the Rifles have a band available for the evening. She is awaiting a reply from the band. She will chase for a reply. Torpoint Sea Cadets band are available, but our budget may not stretch that far.</li> <li>• Switch On – David feels strongly the event should be happy, upbeat and vibrant. As town pioneers the Scouts will be asked if they would like to switch on the Christmas tree lights, with possibly Rose Ramwell pressing the button. Mandy will ask if the Scouts would like this opportunity.</li> </ul> <p>David confirmed that he has ordered the lights and the 35 trees he previously purchased can be used again. He has instructed Balchere to place the lights on the tree again this year. 	<p>David will speak to the Library to confirm that the tree on their building will be ok.</p> <ul style="list-style-type: none"> <li>• There is no further update on the Nadelik Lowen sign. Jacqui will check and update at the next meeting.</li> <li>• The big red button is being borrowed from Looe. David Martell is looking at how this could work in lighting up a small tree after the main tree switch on. This will be a good photo opportunity for children and make them feel involved. David asked where the tree would be supplied from. The location and details will be confirmed at a future meeting. Liskeard Radio can promote this opportunity.</li> <li>• Location plan – The stage will be closer to the fountain than shown on the location plan, being nearer the flower beds. Liskeard Radio will be on the stage and singers before the light switch on. There is no need now for a flat bed trailer. Jacqui will update the plan and send it to Mandy. Mandy will send the updated map to CC once we have confirmation from St John Ambulance.</li> <li>• First aid – 2 quotes for first aid cover had been received. These are significantly more than St John Ambulance. We will await further info from St John. They will be based in the Emily Hobhouse Room. It was noted that last year they confirmed their availability in October. The item is planned to be discussed at the Communications &amp; Engagement Committee.</li> <li>• Mobile food trucks – The Lions have confirmed they won't bring their catering caravan. The Workshed currently has Olive &amp; Co and Cold &amp; Rolled (festive ice creams). The Cornish Pudding Co will be open and Porky Swiners and possibly another coffee trader at the top of the town. The Library and Stuart House will both be open for refreshments in the evening. Rachel will speak to Rumours and Hooked at Highwood. All will be advertised on social media. The income from the stands on the Parade will be in aid of St Petroc, homeless charity. <b>4</b>	<p><b>Funding</b></p> <p>The FEAST application was successful but needs further marketing material before Sally claims it. A photoshoot is planned which will go onto the Feast website.</p> <p>Mandy has submitted Community Chest applications to both Cornwall Councillors. An outcome is awaited.</p>	
<b>5</b>	<p><b>The Access Chain</b></p> <p>Rachel will finalise the accessibility survey. We'll also take account of feedback from other sources eg the Macular Society via Sally.</p> <p>Into Bodmin had created a very short video showing accessibility. If anyone has the ability to create something similar it could be useful. If not, we can post the location map on social media and explain how the accessible area will work.</p> <p>Rachel will check the venues participating in the Trail.</p> <p>Quiet spaces are not to be for unsupervised children. They are for individuals who need some down time, accompanied by carers/parents. We'll need to create a relaxing space in the Public Hall with a member of staff or volunteer on hand.</p>	SH
